• Welcome and opening remarks by Ms. Sharon Hawkins, Board Chair

- Introduction of two new members:
 - Jonathan Askins, State Technology Officer with DIS. Mr. Askins is replacing Yessica Jones

- Doug Melton, Private sector consultant. Mr. Melton is replacing Mr. Taylor Wynn.
- Announced that ARCAN would be streaming the meeting. The stream will be available for 30 days at the ARCAN website.

Agency Report presented by Mr. Shelby Johnson

- Board group photo is out of date and needs to be retaken to include new members. It was also suggested that each member review their biography on the website and submit changes as needed.
- Reviewed usage and statistics for Division of Land Surveys.
- Announced new staff member, Mr. Steven Martin, P.S., who is to join Land Survey Division on March 15, 2021.
- Advocacy and Outreach
 - 911 Board and Next Gen 911 local meetings are ongoing.
 - Gap Analysis is complete, and results are under review.
 - Ms. Hawkins asked about the timeline of official county boundaries switch from draft to final. Mr. Johnson informed that the switch has already been made in the data download. Ms. Hawkins asked for an official announcement to GIS Users Forum.

Old Business

- Reviewed updates on COVID-19 response and ADH support. Mr.
 Johnson announced that Scott Alsbrook has joined ADH as a GIS
 analyst and will be working closely with GIS office.
- NG911 update Focus is currently local 911 service territory review meetings.
- Searcy County parcel mapping approved by Board in December.
 Currently gathering data necessary for a bid request. Goal is to publish bid request at the end of March.
- 2020 Census and Redistricting
 - Census Bureau announced it will deliver P.L. 94-171 redistricting data to the states by September 30, 2021. Typically, Arkansas would receive this data in February.
 - AutoBound Edge software training completed with CityGate GIS personnel. Training included the offices of the Attorney General, Bureau of Legislative Research, Secretary of State, and the Governor's office.
 - Recommendations for local jurisdictions were reviewed including use of 2019 ACS data.

New Business

- County impact will be substantial due to delay in Census data release.
 - CityGate has been asked for variance estimates based on 2019 ACS data. These estimates will give counties advance notice of variances they can expect and will allow them to adjust in preparation of Census data release.
 - Splitting precincts should be avoided as much as possible.
 - Mr. Johnson presented a comprehensive Legislative update, including priority items for both the Land Survey Division and GIS office.

Other Business

- GIS has moved into new offices at 501 Woodlane Street, Suite G-04. Office flooded twice due to severe freezing weather.
- Mr. Johnson proposed having future in-person meetings at the Woodlane address as we have access to conference room space there.

Other Division of Land Surveys Items

- We received around 9400 in 2020 (slightly above average).
- 12 FOIA request since our last GISB meeting.
 - Visit https://surveyor.arkansas.gov/foia-requests/
- Coordinates for around 280 PLSS monuments since purchase of GNSS equipment in 2019. Field operations focused on corner certificates that fall on a county line due to the high number of (GIS) administrative boundaries tied to county lines.
 - Garland-Montgomery county line
 - Howard-Polk county line
 - Franklin-Logan county line
 - Arkansas-Jefferson county line
 - Van Buran-Cleburne county line
 - Perry-Yell County line
- New employee is set to begin on March 15, 2021 in the surveyor position. Primary focus will be on PLSS operations (coordinate control, maintenance, inspection, and perpetuation).

- 15" Black Gum was described in the 1821 GLO field notes








Next Gen 911 Project

2020 Census & Redistricting

 U.S. Census Bureau announced February 12th that it will deliver P.L. 94-171 redistricting data to all states by Sept. 30, 2021.

- Redistricting Software Solution
 - AutoBound training completed with CityGate GIS personnel
 - Awaiting delivery/install of 2019 ACS data



Recommendation for Local Jurisdictions

- 1) Use the 2019 ACS data to estimate the variances in their current districts. For some counties there may be perfectly acceptable levels of variance and they may not require any change. That scenario could be the best of all situations. Pushing variances to higher levels that are within reason likely qualifies as a governmental reason to do so, due to the pandemic and the forced delay, and the hard deadlines in the election calendar.
- 2) Use the 2019 ACS to plan for district changes where necessary.
- 3) To the maximum degree make assignments and plans at the precinct level. Avoid splitting precincts as much as possible.
- 4) Be at the ready for the September delivery of the 2020 data, to analyze their preplanned changes and then adjust as necessary.
