Justice Reinvestment Initiative

- \$1M grant awarded to AR for innovations in information sharing to coordinate crime reduction
- The Justice Reinvestment Initiative (JRI) enables criminal justice systems to improve
 their business management and operations processes by addressing the complex
 factors that drive crime and use of criminal justice system resources.
- Develop and build data-sharing tools such as arrest alert systems that assist in addressing expensive deficiencies in sites' criminal justice systems.
- Projects must seek to break down information sharing silos and challenge current practices that may impede a community's crime reduction strategies.



SREB Accelerating Cross-Agency Data Utilization

- Bill & Melinda Gates Foundation Grant
- Southern Regional Education Board Administering Organization
- Three Step Process
 - Supply/demand mapping
 - Credential mapping and competency modeling
 - Pathway and pipeline modeling
- Initial Focus on Healthcare and Transportation



Jobs and Employment Data Exchange (JEDx)

- A public-private approach for organizing, collecting and using standards-based data on jobs and employment
- Combines and extends Job Data Exchange (JDX) and T3 Innovation Network efforts by the U.S. Chamber of Commerce Foundation
- Envisioned as a national public-private data trust to
 - (1) improve government reporting (e.g., UI wage records);
 - (2) support workforce analytics; and
 - (3) make possible verifiable employment records for worker use (e.g., benefit eligibility)
- Participating States: CA, TX, FL, NJ, CO, KY, AR
- January through September 2022: Build a coalition of partners within each participating state and broadly educate
 public and private partners on the opportunity and approach
- April through September 2022 :
 - (1) One workgroup convenes to prioritize data model and elements;
 - (2) another workgroup convenes to design and test the data system (technology modules and open APIs), and
 - (3) work with partners to review implications for state adoption
- Post September 2022: State partners decide on whether to move forward, and if so, with either a single state or multistate solution







Work-Based Learning

There will be a 2022 Applied Data Analytics training program sponsored by the state of Arkansas focused on work-based learning. Participants will work in teams using registered apprenticeship, pre-apprenticeship, career and technical education, WIOA work-based learning, and employment data to develop research and data products informed by needs identified in the National Governors Association Policy Academy on Scaling Work-Based Learning. The program will provide instruction on using big data tools including SQL and R. Participants will receive training on core data concepts such as record linkage, data visualization, and information quality. The program is open to government agency staff from Arkansas and selected other states.

TANF Data Collaborative



TANF Data Collaborative

The goal of this class is to develop an evidence basis for state and local agencies seeking to support TANF recipients. Participants will develop a variety of new skills in three separate modules. The first module will provide training in how to work with SQL and R. The second module will teach participants how to work with confidential TANF and workforce data to study the employment pathways of TANF recipients and to develop measures of the jobs they get, the jobs they keep, and their success in moving up in the labor market. The third module will focus on understanding the demand side of the labor market and how to use machine learning to characterize the firms that hire TANF recipients and their contribution to labor market success. The results will be to provide participants with (i) an understanding of how to work with similar data in their own state and (ii) the code necessary to produce analytical reports.


