# Approval of GIS Quarterly Board Meeting Minutes of March 2, 2022

- Welcome and opening remarks by Ms. Sharon Hawkins, Board Chair
- NSGIC Update by Mr. Jonathan Duran, NSGIC President-Elect
- Agency Report by Mr. Shelby Johnson
  - o Mr. Johnson referenced the agency report as previously emailed to board members.
    - Inquired if there were questions about the report; there were none.
  - Mr. Johnson introduced Ms. Melissa Walker, the new GIS Office Analyst. He also conveyed the office is now fully staffed with the addition of Ms. Walker and contractor Mr. Wes Garrett.

#### Old Business

- Redistricting
  - All school board zones are complete and published.
  - Any redistricting modifications should end by September or October.
  - House and Senate data will be updated when new members take oath of office, probably the second week in January 2023.
- o NG911 Project
  - Data preparation and validation by staff to enable spatial routing to function.
  - 911 Board procurement of data validation services has gone to bid and should have results and implementation by August.
- Searcy County Parcel Mapping Grant Update
  - Schneider Corp. has so far provided about one-third of the parcel data committed to under the grant.
  - Completion of the project is anticipated before our next board meeting.
- Statewide Orthoimagery Funding Status Update
  - Funding is now in place for statewide one-foot imagery.
  - There is a possibility of limited six-inch imagery utilizing leftover funds.
  - Imagery acquisition will take place January of 2023.
- New Pickup truck for Division of Land Surveys
  - The Board voted at the March meeting to approve the purchase of a new truck for the Division of Land Surveys. Since that time, a truck has not been available under the state's contract. According to fleet managers at dealerships in Little Rock and around central Arkansas, trucks meeting the state contract specifications would likely not be available until 2023. Additionally, local dealerships who were not on state contract, and had similar work trucks available, were quoting prices that exceeded the contracted rate.
  - Mr. Johnson sought guidance and options from the Office of State Procurement. OSP recommended utilizing the "Request for Authority to Solicit for Vehicle" process, whereas a bid request can be made outside a state contract but only under specific conditions. The Board was asked to vote to approve using this procurement method to expedite the truck purchase.

Motion to approve GIS use of Request for Authority to Solicit for Vehicle in the interest of moving forward with the purchase of an agency truck.
